Please note these important changes for 2010 - 2011:

The program will run only when school is in session. **On one-session days, the program will begin at 12:42 p.m. and end at 3:45 p.m. Arrangements must be made for prompt pick-up by 6:00 p.m. on full days or 3:45 p.m. on one-session days.** A \$25.00 per half-hour fee will be charged for late pick ups.

The fee structure for use of the program is as follows. **A discount of \$50.00 per family is in effect if more than one sibling attends the program. No other discounts apply.** A non-refundable registration fee of \$50.00 per family is due September 1st or when you start the program.
